All Tenders must be accompanied by a Tender Security in the form of a **Bank Guarantee Issued through Local Correspondence Bank in Tanzania** in the amount of **2% of Bid Price** in format provided in Tender Document. Bid Securing Declaration will not be acceptable. **Tender not accompanied by a Tender Security will be rejected.**
